#### 1) Post Award NEPA Review Process

NOAA, in particular the National Ocean Service (NOS) and its Program and Staff Offices (P/SOs), engage in a wide range of activities that have the potential to impact the environment. NOS P/SOs are responsible for ensuring their activities are carried out in compliance with all applicable federal environmental regulations and Executive Orders (EOs) by conducting a National Environmental Policy Act (NEPA) analysis of all financial assistance awards. To that end, IOOS prepared a Programmatic Environmental Assessment (PEA). The most recent draft of the PEA can be found online here: http://www.ioos.noaa.gov/about/governance/environmental\_compliance.html. By accepting this award, the recipient agrees:

- a. No funds will be expended on any activities that were not sufficiently defined at the time this 5-year cooperative agreement was proposed. Before expending funds from this award on any activity taking place in the natural environment, the recipient must demonstrate compliance with applicable environmental regulations by providing the IOOS program office with details of the activity, including copies of all permits, licenses, or authorizations received by the recipient from a permitting, licensing or authorizing agency. - 3. Glider and Transects
- 4. Moorings/Buoy Stations/Fixed Arrays
- 5. Doppler and Wave Imaging Marine Radar

The recipient must work with the program office environmental compliance coordinator to satisfy this SAC.

#### 2) Data Management and Communication (DMAC) Plan

### 5) Performance Progress Reports

Project Progress Reports are due on a semi-annual basis, no later than 30 days following the end of each six (6) month period from the start date of the original award. A comprehensive final Project Progress Report is due within 90 days after the award expiration date and will include the last interim reporting period.

# 6) Leveraging Federal Funds in Conjunction with Non-Federal Funds

There is no prohibition against the funds awarded on this cooperative agreement from being leveraged against non-Federal sources, i.e., state and local governments or private sector industries, as determined by the non-Federal entities. Notwithstanding any such leveraging, the recipient of this award must execute this project in accordance with the terms and conditions.

# 7) Emergency Response

#### 9) Multi-Year Special Award Condition

The award period and budget(s) incorporated into this award cover a 5-year period for a total amount of 20,000,000 in Federal funds. However, Federal funding available at this time is limited to 2,774,532 for this funding period. Receipt of any prospective funding is contingent upon the availability of funds from Congress, satisfactory performance, continued relevance to program objectives, and will be at the sole discretion of the Department of Commerce.
